1. This Registration Certificate shall not relieve any of the statutory obligations of the concerned buying house. The buying house authority shall be responsible for any mishap caused by any breach of condition or failure to comply with the rules.
2. This Registration Certificate shall have no involvement in any financial transaction with national/international government or non-governmental financial organization in implementing the buying house.
3. If any changes happens in ownership or address of the buying house must be notified to the Department of textiles immediately.
4. The registered buying house should extend their full support to any survey or inspection conducted by the government or collecting information.
5. The buying house authority should inform the Department of textiles in case of the government privileges received.
